Excerpt from the Faculty Regulations for Doctoral Studies (*Promotionsordnung*) of July 29, 2015

Excerpts applicable for Physics and Astronomy:

To § 6 section 3:

As part of their education, doctoral students of physics are obliged to attend existing doctoral programmes (e.g. Graduate Seminars), that may consist of block courses, journal clubs or other specifically arranged lectures that are rated equivalently. When the doctoral candidate on completion of his/her studies applies for entrance to the final examinations, he/she must provide proof that he/she has attended the requisite courses (§ 9 section 3 f.)

- It is mandatory that the candidate attend courses amounting to at least 4 SWS (SWS refers to the number of hours per week during the semester) in total, whereby a block course such as those offered within the Graduate Days count as 1 SWS. For students of the Graduate School of Fundamental Physics, the mandatory course attendance requirements are 16 SWS in total, whereby it is expected that the student should attend 4 SWS on average during the first two years.
- The content of the courses listed is to be regarded as examination material for the final examination.
- In addition, for doctoral students in the field of Astronomy, the special ordinances of the course plan for Astronomy must be followed.

The only exceptions to these rules can be made for students who are required to follow the study programme of a Graduate College within the framework of the German Research Foundation (DFG).

To § 10 section 1:

The examination committee consists of four examiners, two of which evaluate the thesis (referees) plus two further examiners. The members of the examination committee represent at least three differing specialities in accordance with the subjects listed in the Appendix to § 10 of the Regulations and which are deemed to be in a sensible combination with the dissertation specialization of the candidate.

Requirements for Doctoral Students with regard to teaching

The Department of Physics and Astronomy regards teaching as a vital component in the education of doctoral students, not only to reinforce their knowledge in a particular subject of physics, but also to aid in developing their communication skills. Teaching is also often simply a rewarding exercise for the doctoral student.

The following is applicable to all doctoral students in physics and astronomy:

- 1) It is assumed that every student, during the course of his/her doctoral studies, will participate in teaching. This teaching requirement is independent of the mode of financing that has been made available for the doctoral study.
- 2) The Institutes and workgroups have the opportunity of deciding individually which students in which semesters should take up a teaching activity, so that the teaching per Institute and for the Department of Physics and Astronomy is adequately covered in each semester. This flexibility allows groups that have beam time elsewhere, for example, to fit the teaching into their research schedules.
- 3) The Department of Physics and Astronomy expects that, independent of the internal regulations of each Institute for the required duties of the student with regard to teaching, each student *performs at least 2 teaching activities* of 2 "Teaching Units*" in total during the course of his/her doctoral studies and provides proof of this in order to register successfully for the final examination.

* One "Teaching Unit" is defined to be one of the following:

- Tutoring one exercise group within the courses of theoretical or experimental physics or computer science (2 SWS plus preparation and correction of exercises and tests)
- Assistance in practicals (beginner, advanced, or computer practicals), 6-8 SWS (2 afternoons at 3-4 hours during the semester, or vacation practicals (4 weeks amounting to the same length of time)
